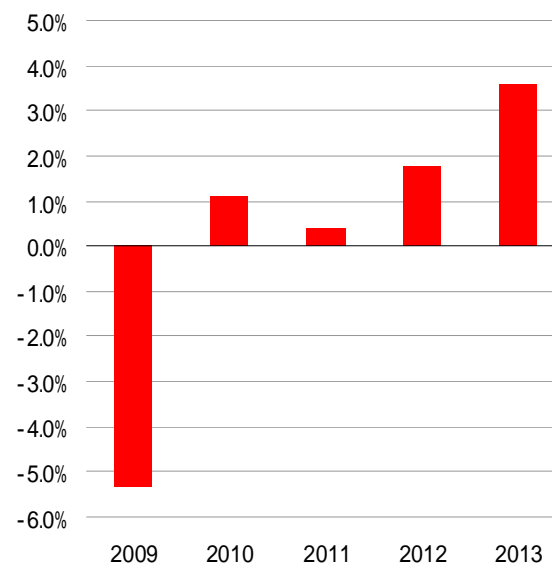
Return on Assets (ROA)

総資産経常利益率



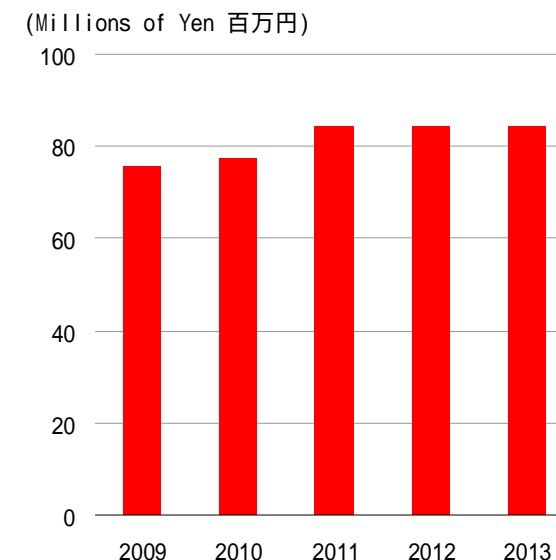
Return on Equity (ROE)

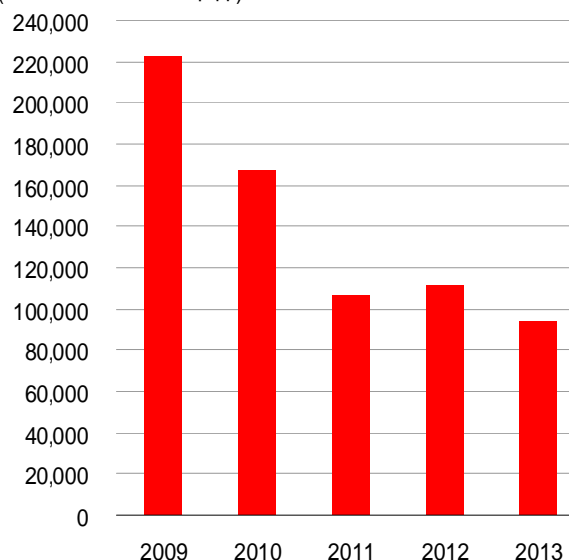

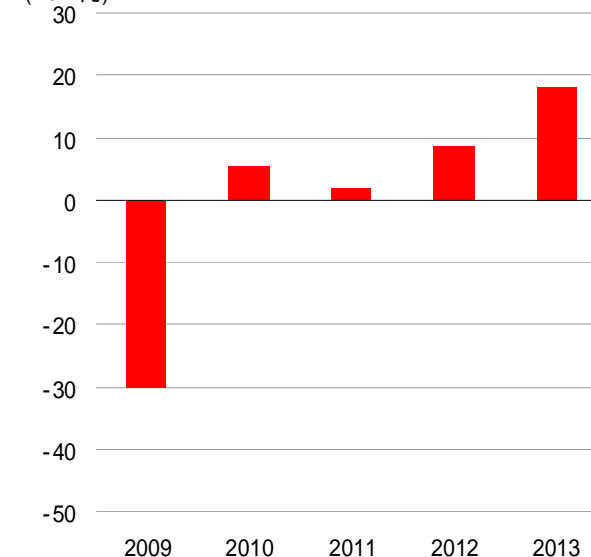

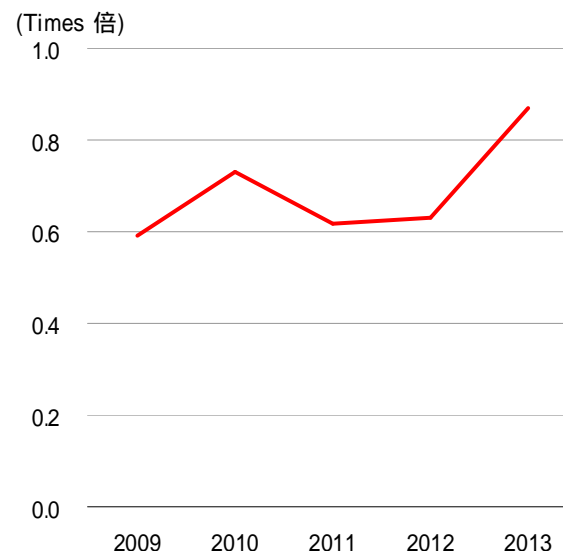

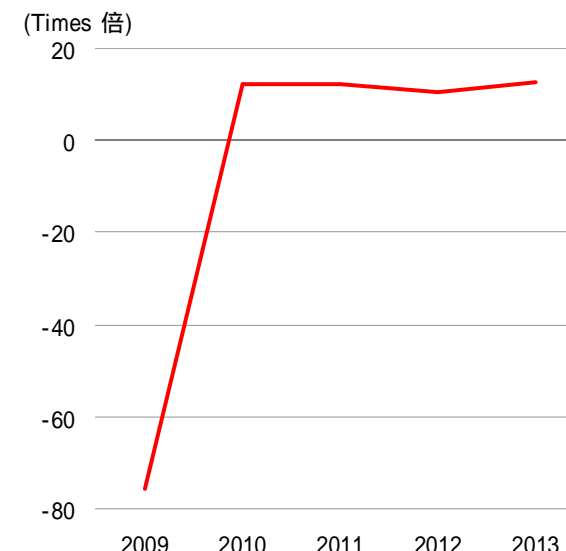
Price/Earnings Ratio(PER)

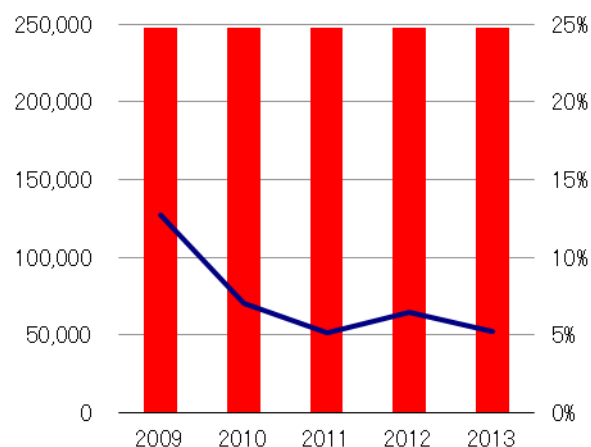

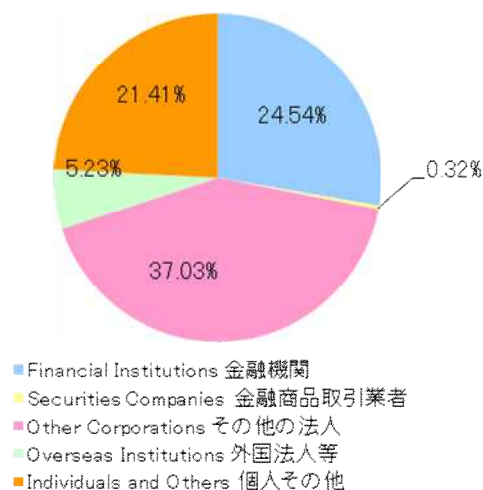

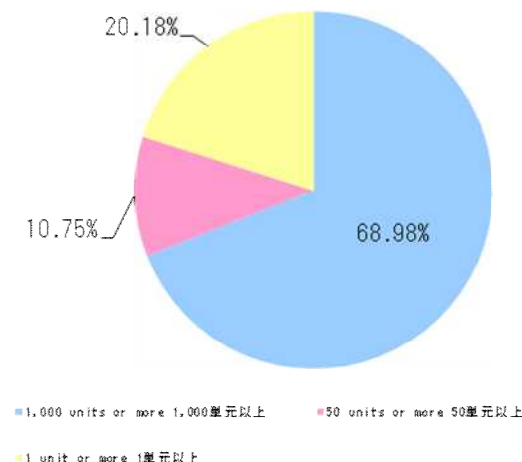
