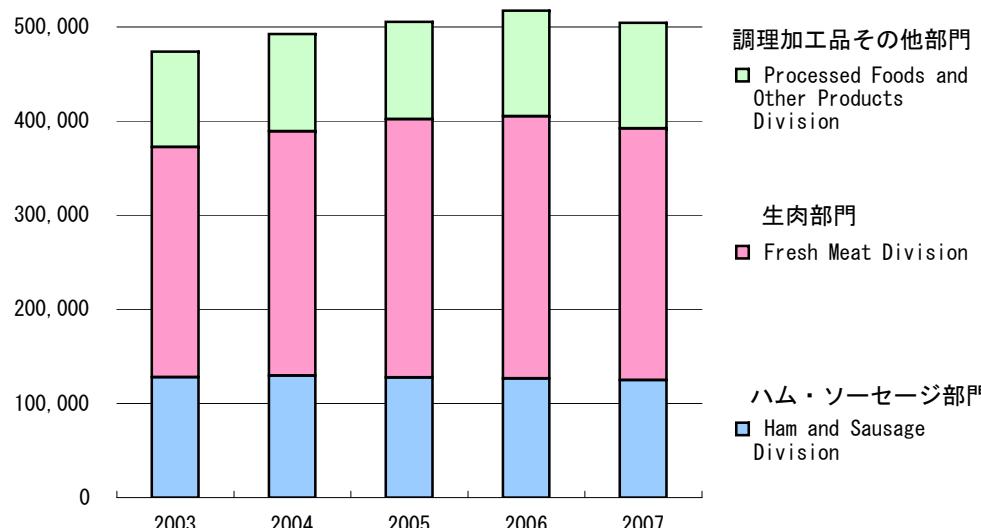

## Net Sales by Product Division

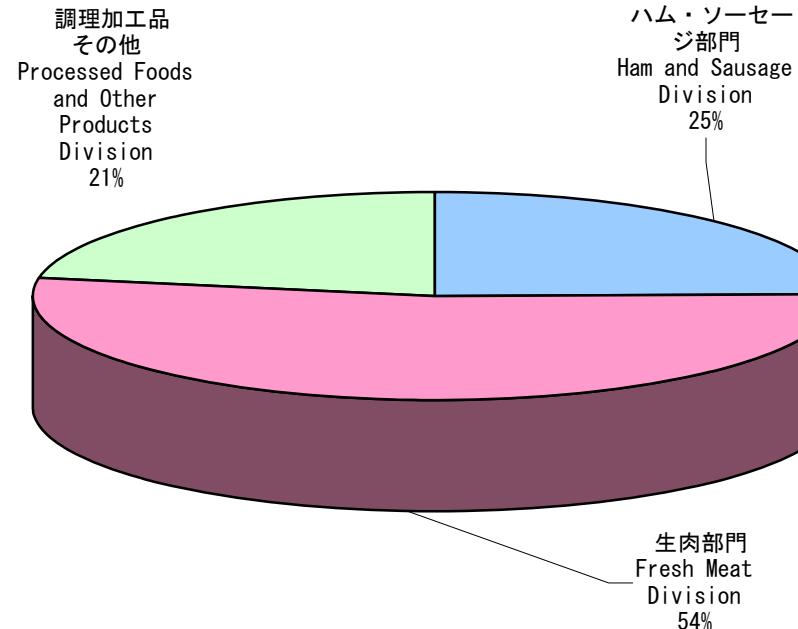

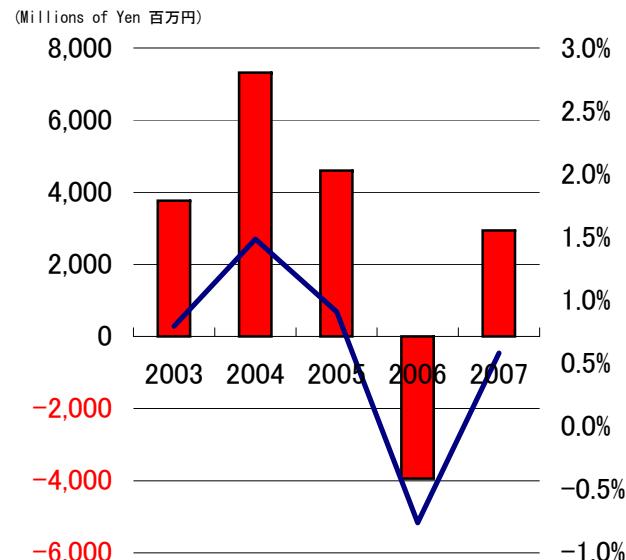

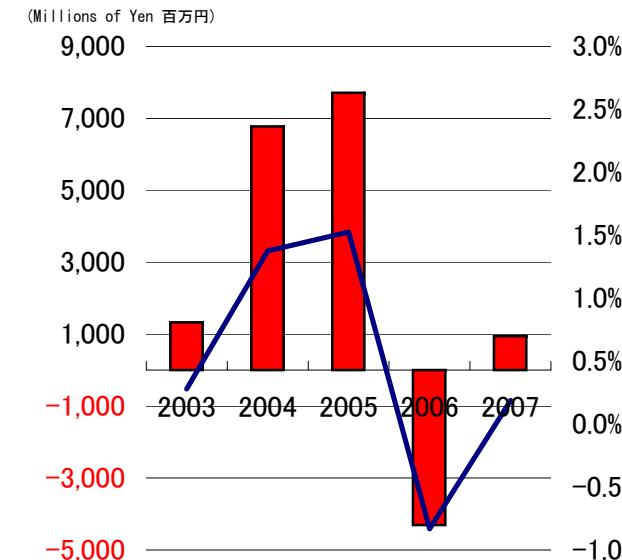
#### 営業利益、売上高営業利益率

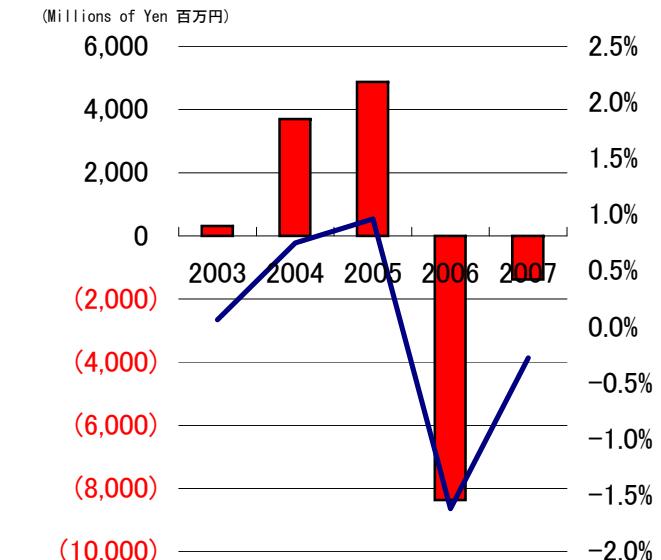

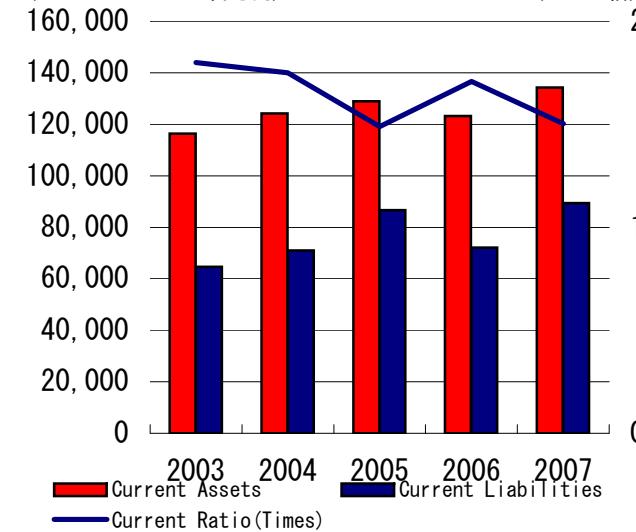

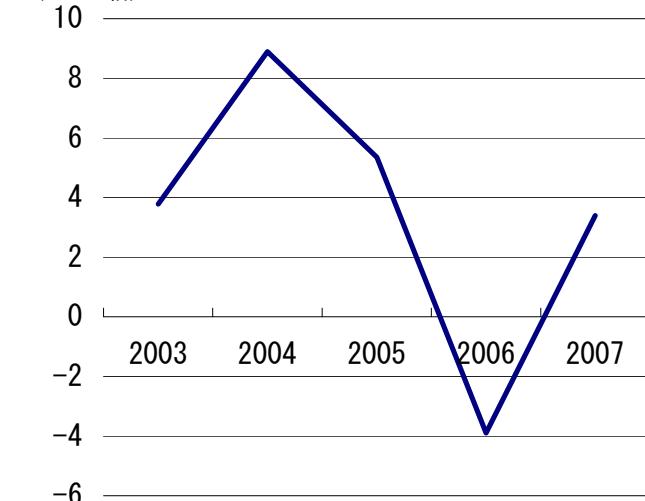

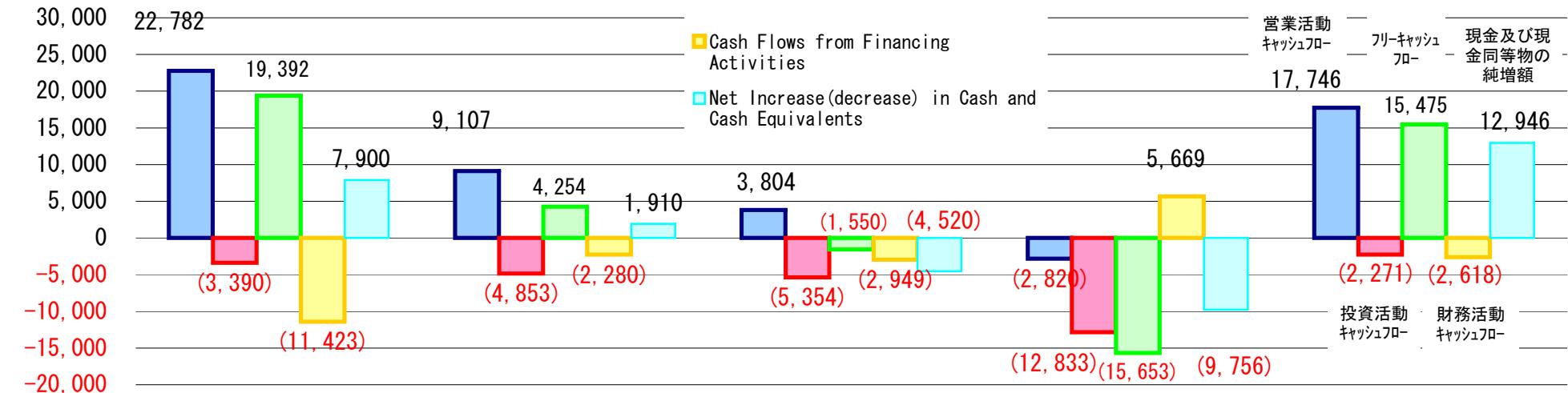

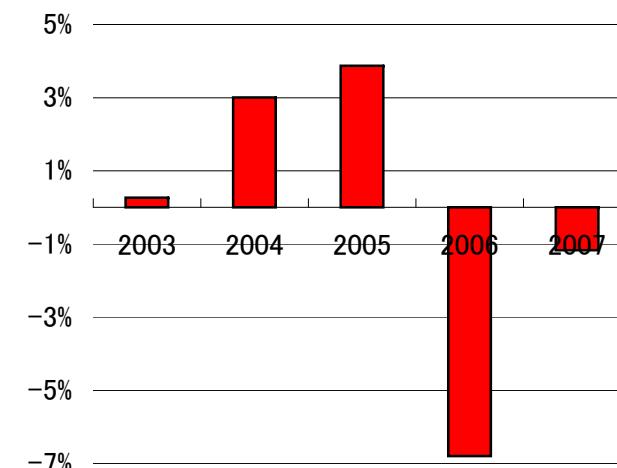
### Return on Assets (ROA)

総資産事業利益率



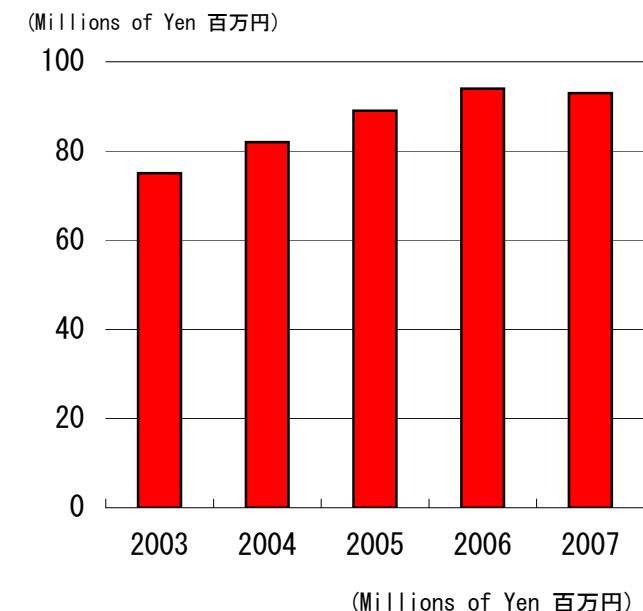
### Return on Equity (ROE)

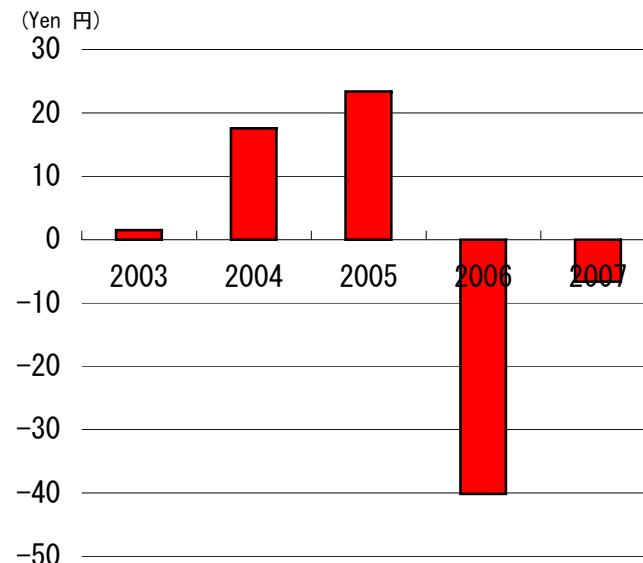

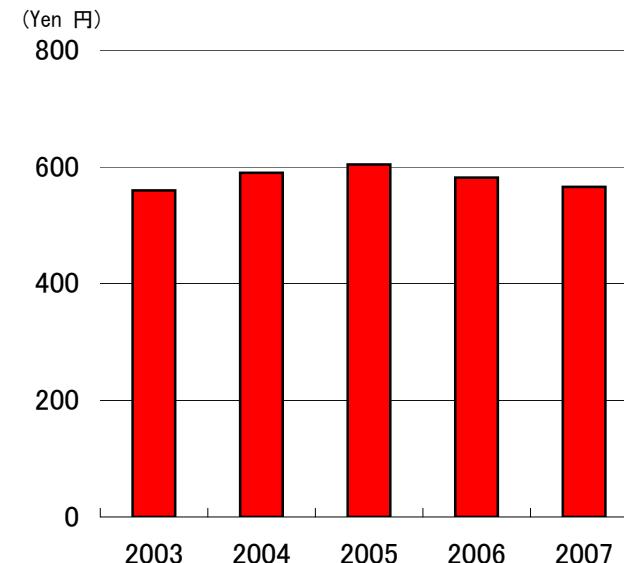
**Net Income(loss) per Share**

1 株当たり当期純利益（損失）



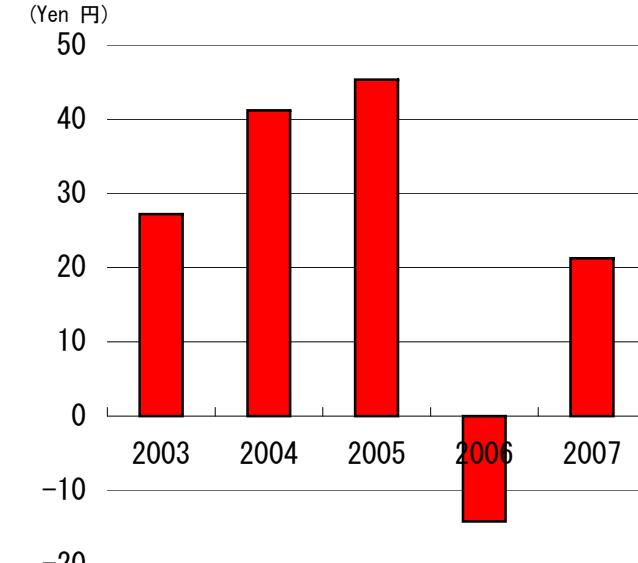
**Net Assets per Share**

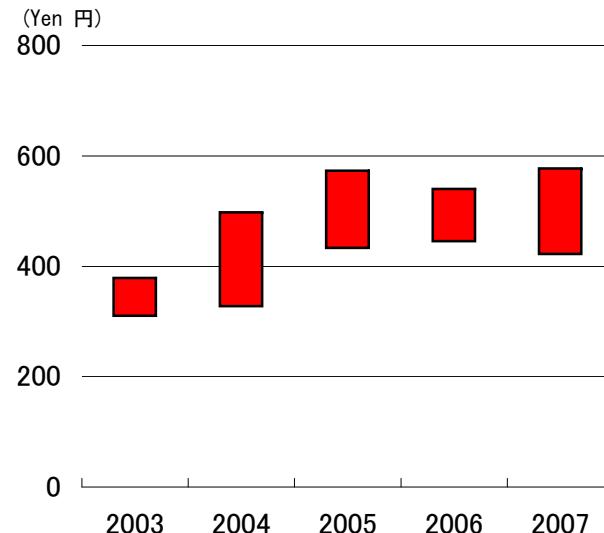

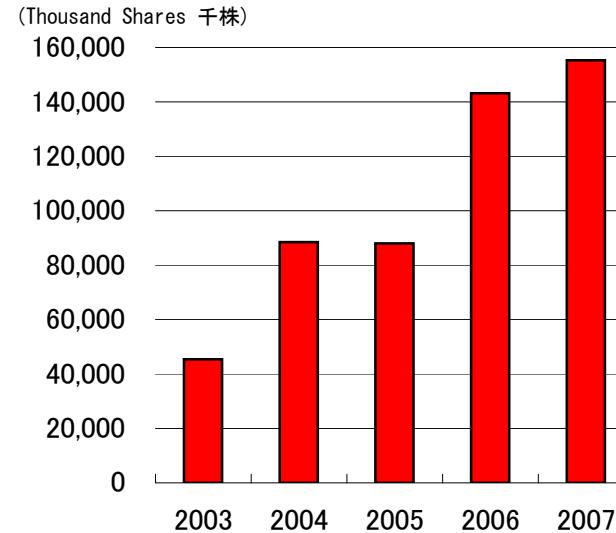
### Common Stock Price Range

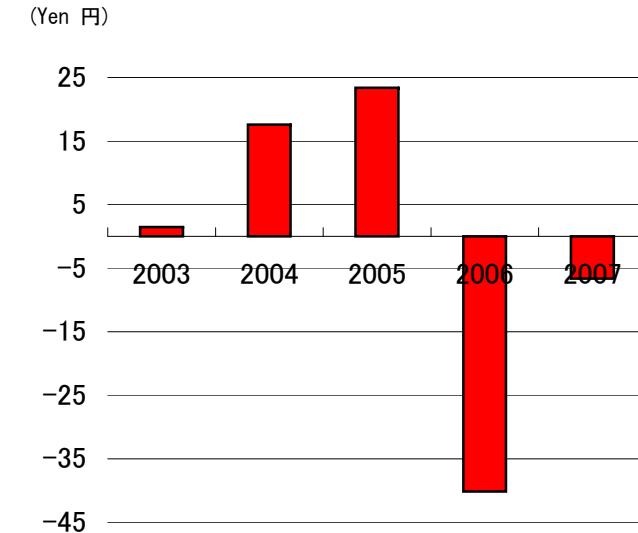

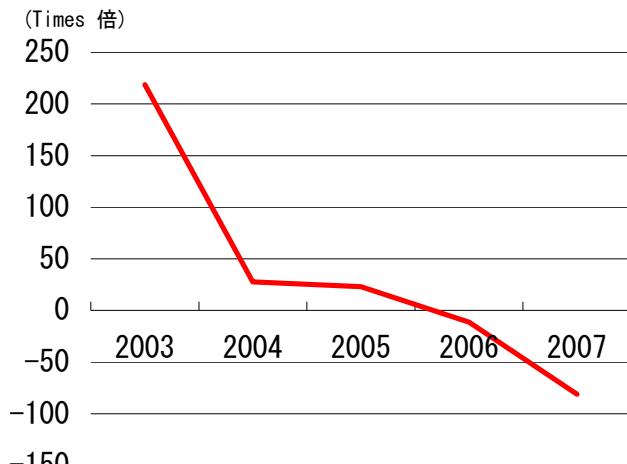

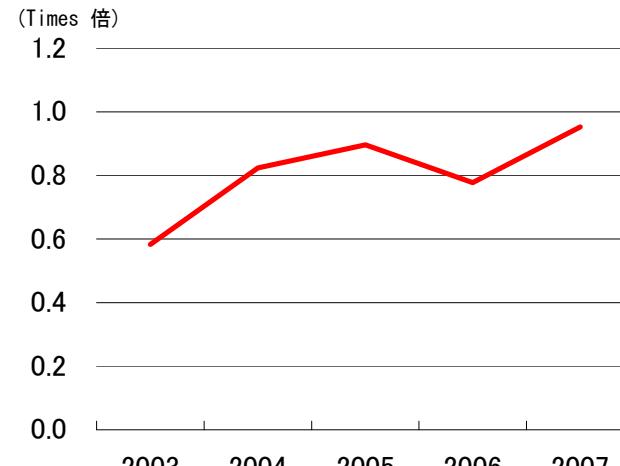
**Price/Earnings Ratio (PER)**

株価収益率



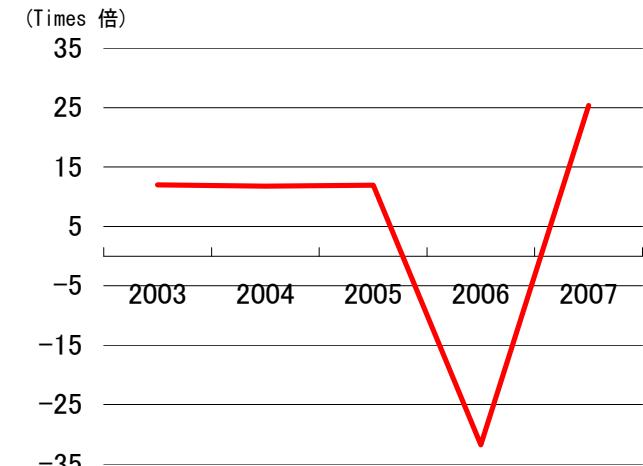
**Price/Book Value Ratio (BPS)**

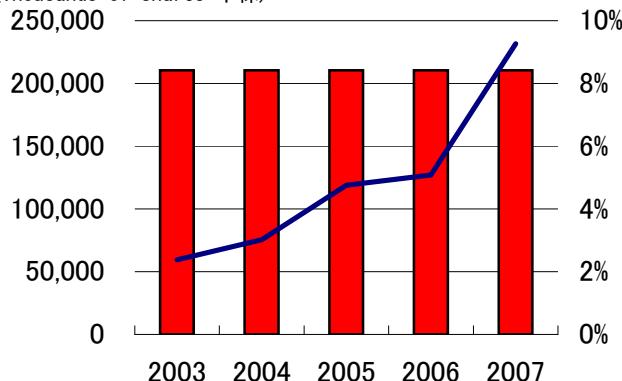

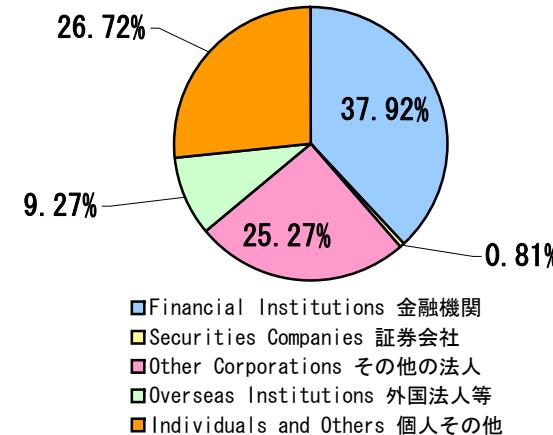

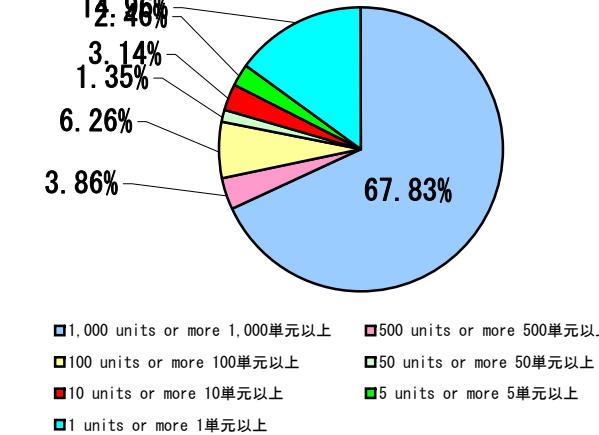
### Breakdown of Issued Shares by Shareholder Type\*
