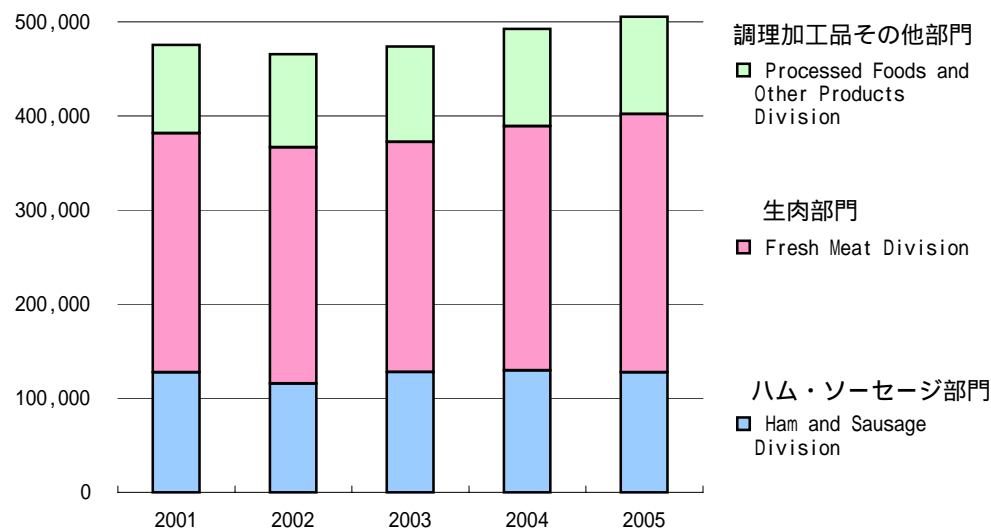

Net Sales by Product Division

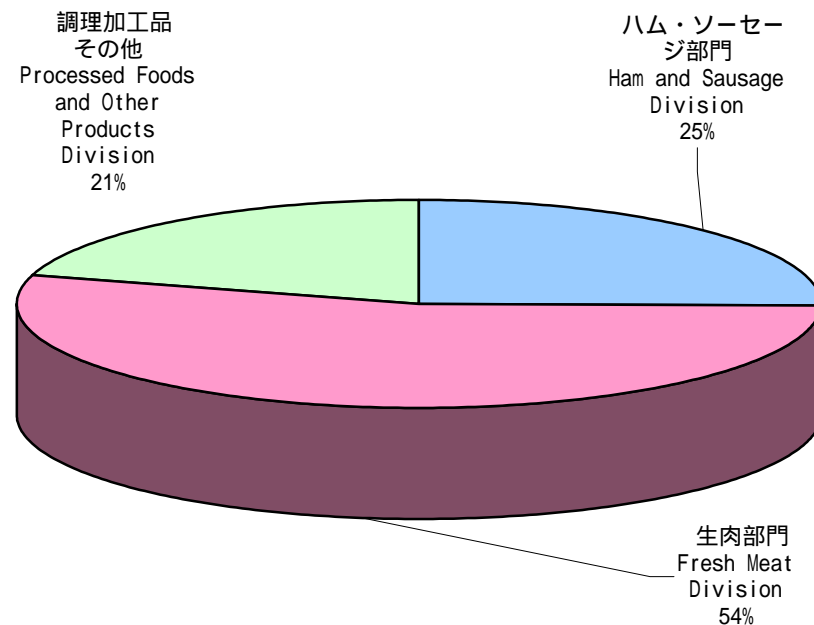

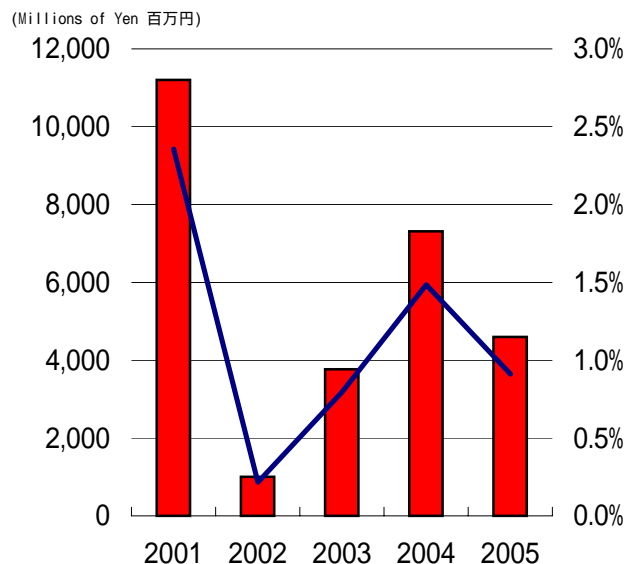

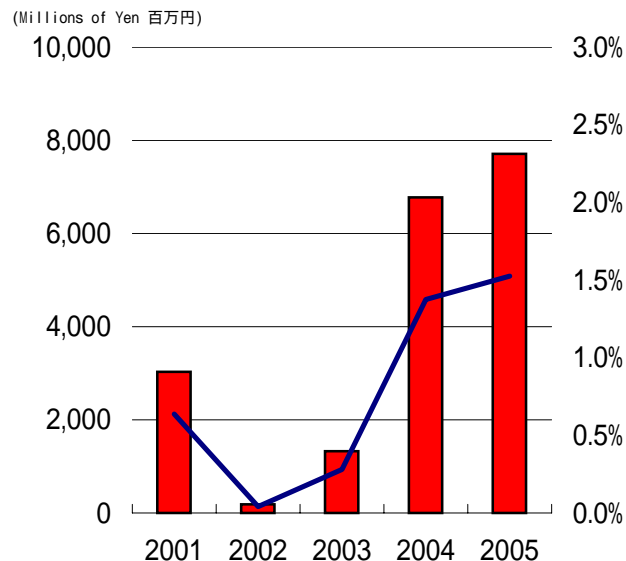

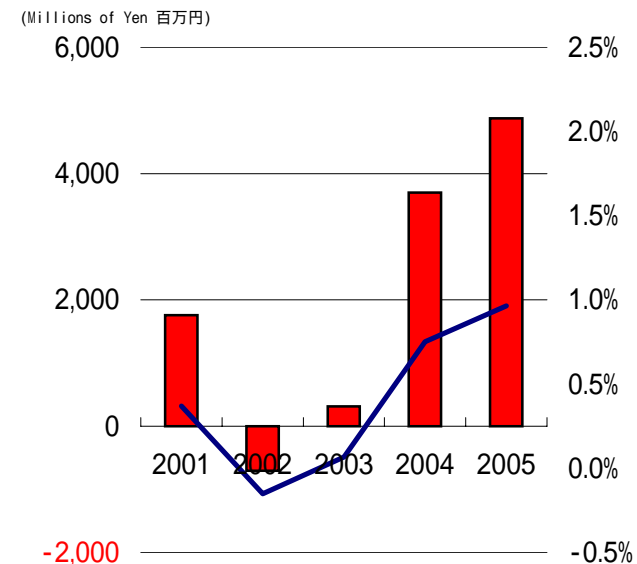

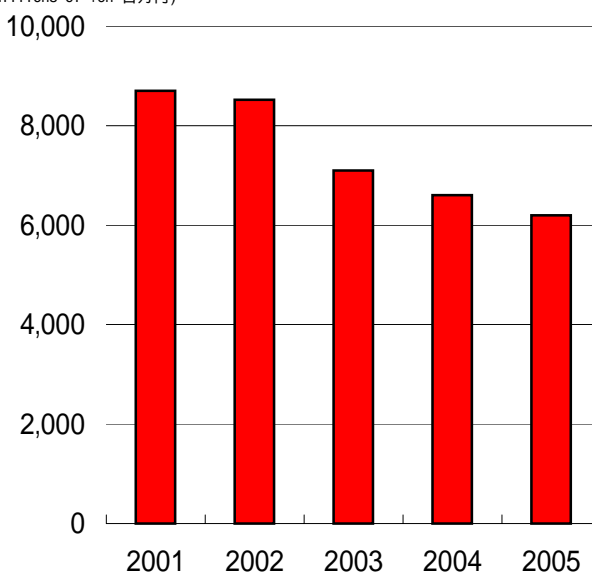

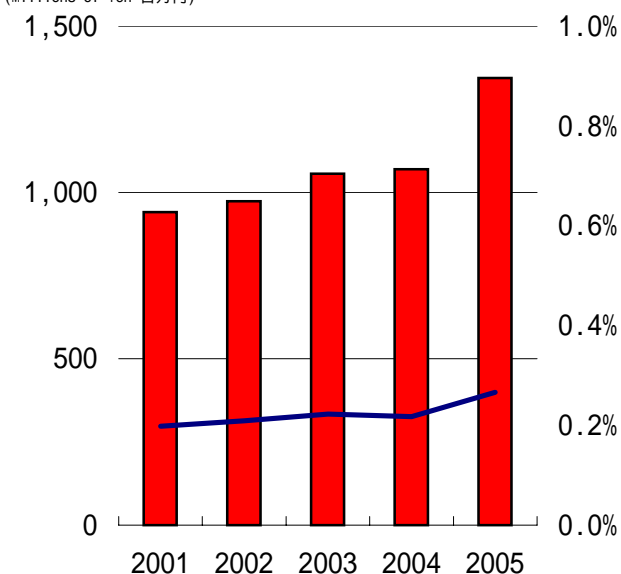

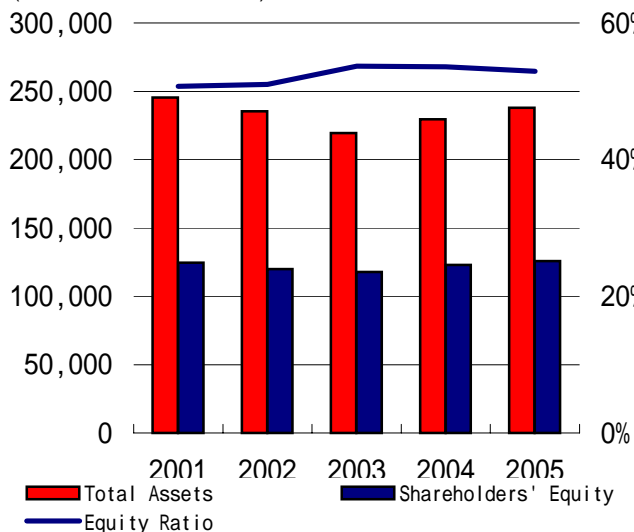

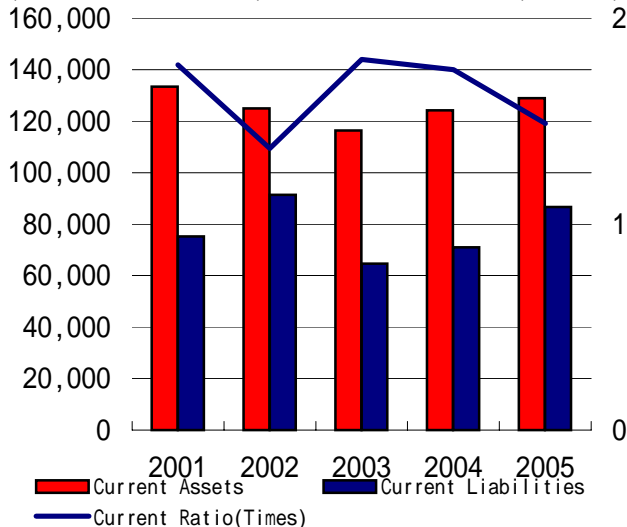

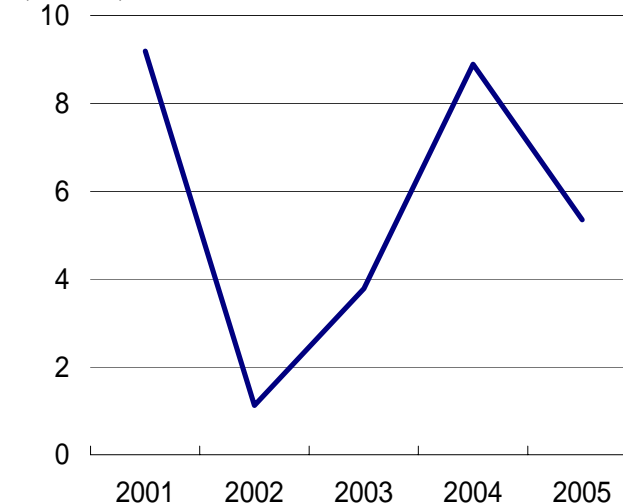

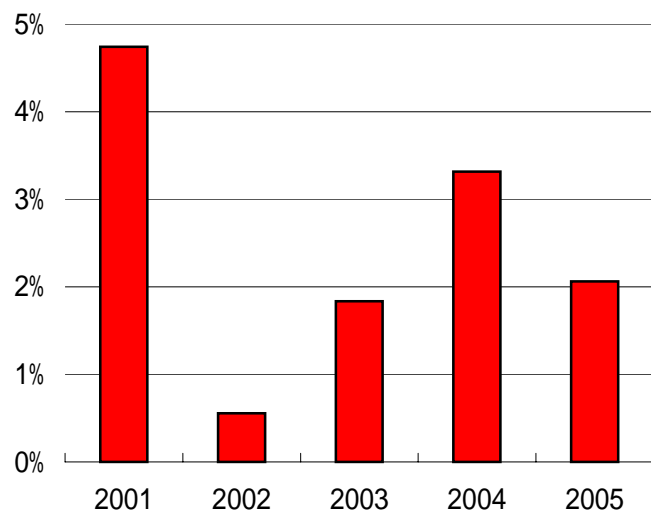

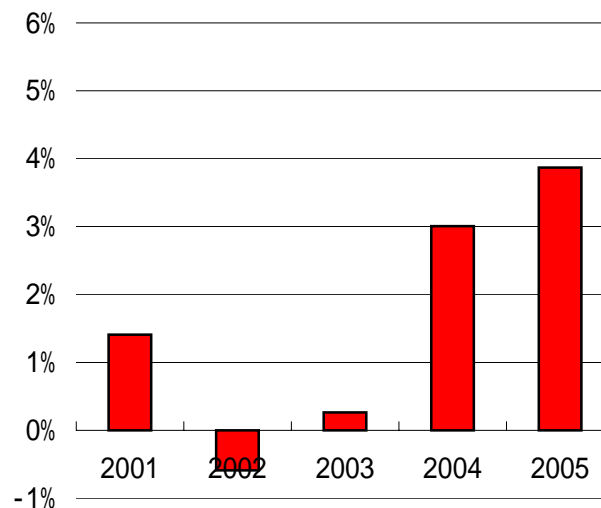
Return on Assets (ROA)

Return on Equity (ROE)

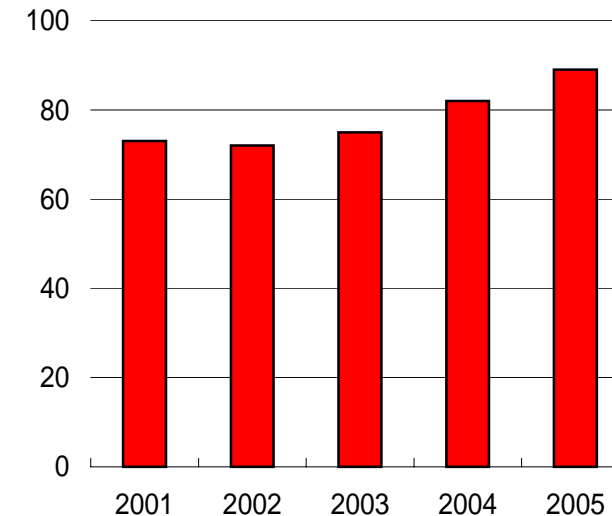

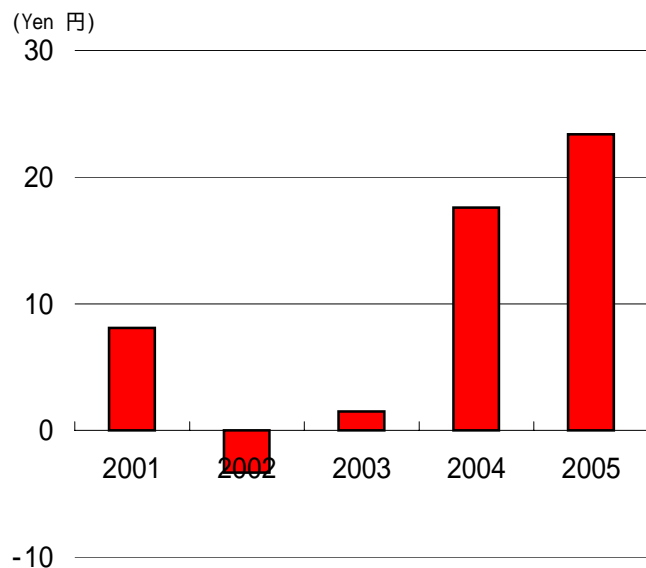

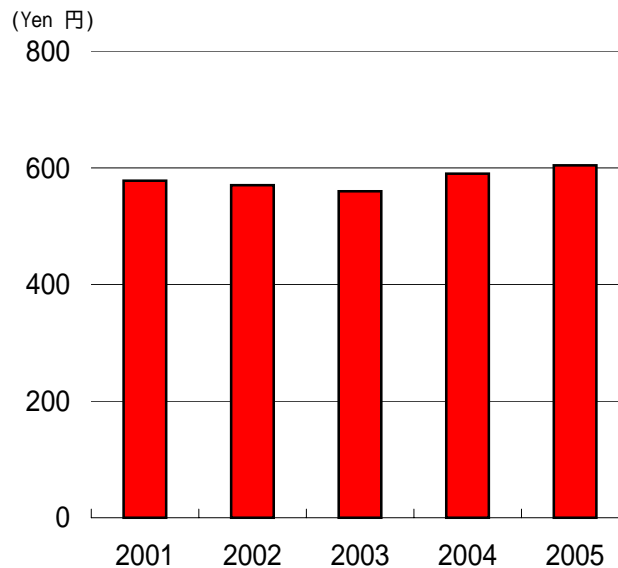
Net Income(loss) per Share

1株当たり当期純利益(損失)



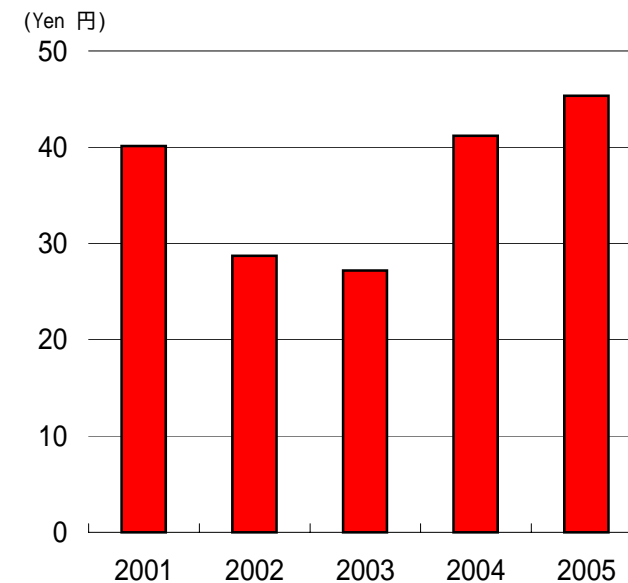
Shareholders' Equity per Share

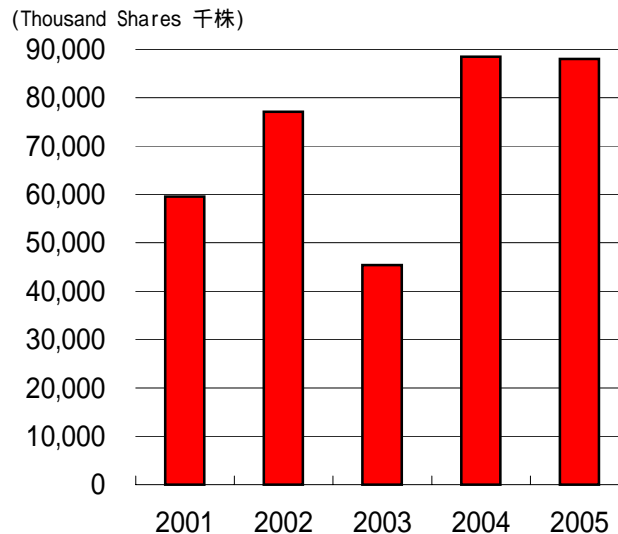

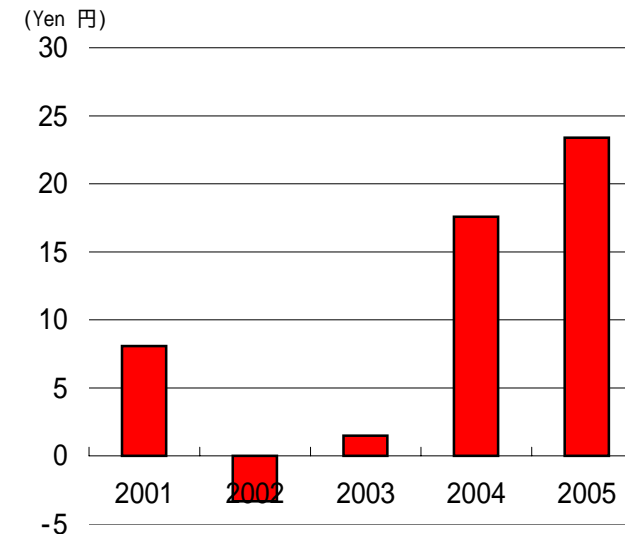

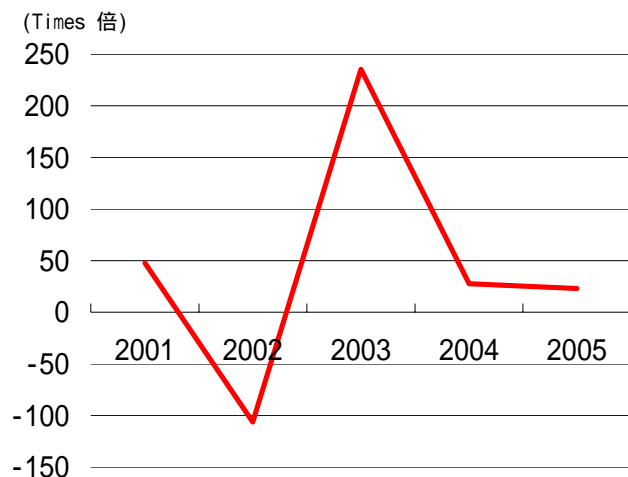

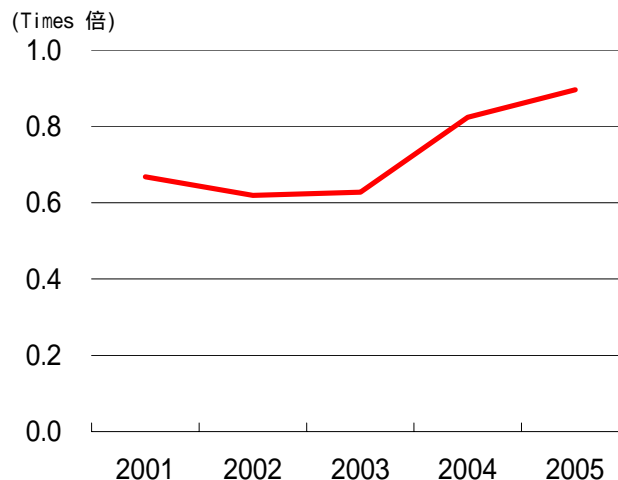
Price/Earnings Ratio (PER)

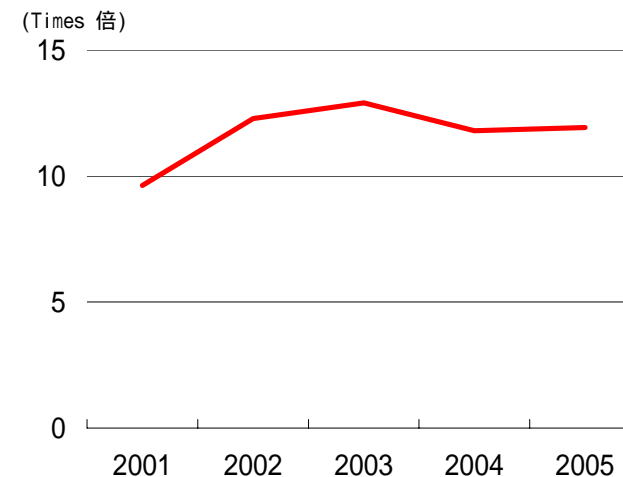
Price/Book Value Ratio (BPS)

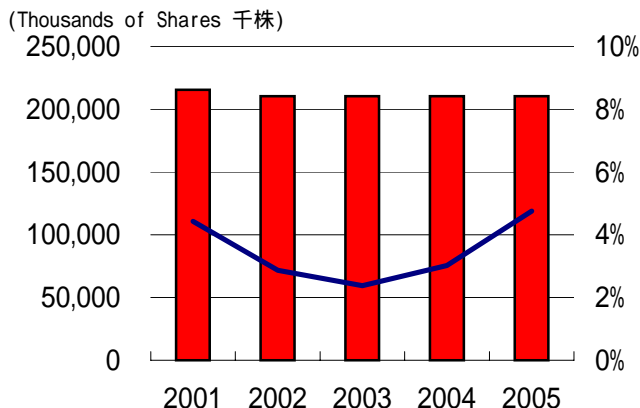

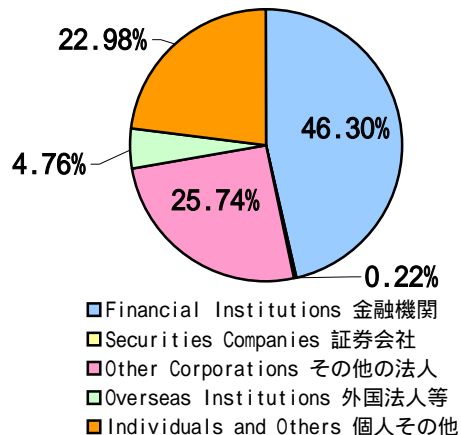

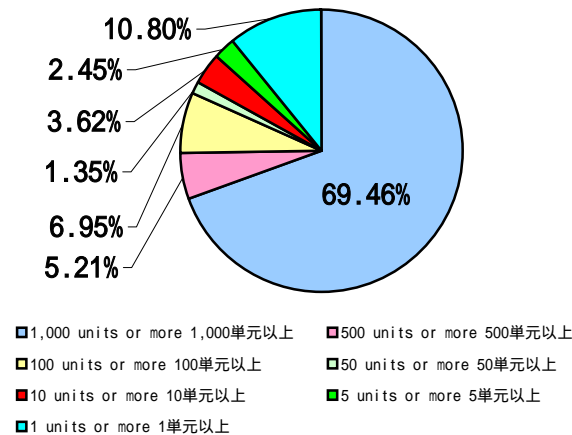
